4. Pre-bid meeting shall be held at **Gokarneshwor Municipality, Jorpati, Kathmandu** at **14:00 hours 2076/06/14**
5. Electronic bids must be submitted to the office **Gokarneshwor Municipality, Jorpati, Kathmandu** through PPMO website www.bolpatra.gov.np/egp on or before **12:00 hours on 2076/06/26**. Bids received after this deadline shall be rejected.
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours 2076/06/26** at the office of **Gokarneshwor Municipality, Jorpati, Kathmandu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **those stated above** which shall be valid for **30 days** beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
